ICB GP Quality Contract - Setting the record straight (L&SC)

Message from your LMC CEO, Dr Adam Janjua

There has been a lot of discussion and debate around the ICB GP Quality Contract (GPQC) in the past couple of weeks. There has also been some critical comments made about myself and to a lesser extent the LMC Consortium team. This is why I am writing to you to set the record straight as there seems to be some confusion about our involvement in the process of agreeing the GPQC.

We are aware that despite Eclipse having been utilised in some areas of L&SC for some time, some colleagues in areas where this is due to be introduced have raised IG concerns awaiting ICB assurances.

10th Anniversary of the LMC HR Service

The LMC HR Service has just celebrated completing 10 successful years since inception. During that time the service has dealt with over 23,000 queries for advice and support from Practices. Whilst many have been routine queries, a significant number have involved highly complex and difficult cases, a substantial number of which have been resolved with satisfactory outcomes for Practices, with specialist support, where needed, from experienced and specialist employment lawyers provided free of charge.

All core services are provided free of charge, funded via the GP levy which enables access to experienced HR practitioners, able to provide bespoke and flexible advice on a case-by-case basis.

In addition, the service provides legally tested template policies, contracts, and other HR related policy documents.

In view of the success achieved in delivering our core services, the HR team are now exploring service expansion into non-core areas including organisational development, team building, work force/succession planning, to name a few.

National Minimum and Living Wage April 2024

With effect from 1st April 2024, National Minimum and Living wage rates:

- For those aged 16/17, and apprentice rates £6.40 per hour (21.2% increase)
- For those aged 18-20 £8.60 per hour (14.8% increase)
- For those aged 21+ £11.44 per hour (9.8% increase)

All the pay uplifts listed above are statutory and employers are legally bound to apply these as a minimum rate of pay where appropriate. However, the percentage increases quoted, are significantly above the cost-of-living formula. used by Government generally to fund other annual cost of living increases.

In practical terms, this significant differential is likely to the lead to the following consequences:

- Erosion of existing pay differentials at the lower end of pay structures.
- A gradual increase in numbers of staff subject to annual living wage enhancements in the future.
- Some increase in pressures on pay budgets.
- Tensions and dissatisfaction among different staff groups, particularly those at the lower end
 of the pay structure.

In this context, it may be appropriate for Practices to review and reconsider existing recruitment strategies, and to reflect on how they might deal with in-house tensions between living wage / non-living wage staff groups.

The <u>LMC HR service</u> are available and happy to support Practices in terms of managing these challenges.

Destination Net Zero - L&SC only

GP practices have the opportunity to join the 'Destination Net Zero' Programme to ensure CQC compliance re environmental sustainability, save money and support staff and patient wellbeing. Lancashire and South Cumbria ICB have teamed up with the Chamber Low Carbon programme funded via the UK Shared Prosperity Fund provided by HM Government as part of the Levelling Up agenda and administered by the Lancashire local authorities.

Practices signing up to the programme will have an advisor assigned to them, a review of your practice and the calculation of your carbon footprint will be conducted. This will enable the production of a Green Plan and a Carbon Reduction Plan in line with the Cabinet Office's template under Procurement Policy Note 6/21 – Taking account of Carbon reduction Plans in the Procurement of Major Government Contracts which as of April 2024 will apply to all NHS contracts for your practice.
